# GLOBAL REGULATION OF MARKETS

The Master is the result of an agreement between the **UNIVERSITÀ DEGLI STUDI DI ROMA “LA SAPIENZA”** and the **LIBERA UNIVERSITÀ INTERNAZIONALE DEGLI STUDI SOCIALI “LUISS” GUIDO CARLI**. Lectures and conferences will be given by professors from European and extra-European Universities, judges, experts, high civil servants from public and private institutions.

**English** is the official language of the Master. **DIRECTOR OF THE MASTER:** Prof. Marco D’Alberti, full professor of Administrative law at “La Sapienza” University.

**OBJECTIVES:** The Master aims to provide participants with an in-depth knowledge on topics concerning the regulation of global economy, which are today of primary importance in the scientific and political debate. In particular, the Master offers specialized preparation for recruitment within independent agencies and other public administrations, universities, international and EU organizations, entrepreneurial groups.

**ORGANIZATION AND TEACHING ACTIVITIES:** The Master activities last **one year**. Teaching activities will be held twice a week and will take place at Università degli Studi di Roma “La Sapienza” and at the Libera Università Internazionale degli Studi Sociali LUISS Guido Carli, from February 2016 to December 2016. Lectures will be divided into a series of modules. Each of the following modules will analyze particular topics with the aim of developing specific professional profiles: **History and theories of economic regulation, Public regulation and competition in the current phase of globalization, Free movement of goods and services, Transnational contracts, Financial markets regulation, Regulation of electronic communications, Energy regulation and environmental regulation, Regulation in the food and pharmaceutical sector, Ethics and regulation.**

**ELIGIBILITY AND APPLICATION:** The number of participants will be between **10** and **40**. The Master is intended for graduate students with a five-year degree in Law, Economics, Political Science, Statistics, Sociology (and equivalent degrees at European and international level).

Applications must be submitted to Università degli Studi di Roma “La Sapienza” before January 27<sup>th</sup> 2016 under the conditions provided for in the official notice already published on the Master website ([www.globalregulation.uniroma1.it/en/admission/notice](http://www.globalregulation.uniroma1.it/en/admission/notice)) and in the bulletin of the University.

**REGISTRATION FEE, SCHOLARSHIPS AND INTERNSHIPS:** The registration fee, payable in installments, amounts to € 5.000. Scholarships may be awarded to the worthiest applicants in order to partially or fully cover the fee. Stages within private and public institutions will be organized at the end of the course.
